Box M. Internal Auditor commented 'Evidenced in 2021 prior to website 'hacking'.

Explanation – Parish Council website was compromised and an email received from National Cyber Security Centre alerting Parish Council to issues in December. At the January Parish Council meeting on 11th January, the Parish Council agreed to set up a new website (minute reference 14/22).

Population of the new website commenced and is ongoing. Therefore the Internal Auditor commented as above.
